**MEMORANDUM OF UNDERSTANDING
BETWEEN
UNIVERSITY OF THE PHILIPPINES MANILA,
PHILIPPINES
AND
UNIVERSITY OF GLASGOW,
UNITED KINGDOM**

The Memorandum of Understanding (hereinafter called "MOU") represents the cooperation and understanding between University of the Philippines Manila (hereinafter called "UPM") and University of Glasgow (hereinafter called "UG") and is not intended to have legal or binding effect. UPM and UG shall agree to foster cooperation for teaching and exchange corresponding to the broad range of health care and international medical cooperation.

1. Within the fields to be mutually designed, both UPM and UG can broadly agree to the following general forms of cooperation:
 - a. Graduate studies and continuing education;
 - b. Exchange of information and materials in fields which are of interest to both universities;
 - c. Exchange of experts, faculty members and staff for research and training;
 - d. Development of student exchange programs for research and clinical training;
 - e. Holding of lectures, conferences and symposia;
 - f. Other academic exchange upon which both universities agree.
2. Both of the above named parties also agree to strengthen cooperation and partnership.
3. Details of the arrangement and stipulations on the academic and scholarly activities mentioned above in Item 1 shall be determined separately by mutual consent.

4. Any costs incurred in relation to the general forms of cooperation mentioned above, including accommodation and domestic transport costs, shall, in principle, be borne by the party sending the delegation or individual, unless otherwise agreed. Neither party shall in any way be responsible for personal costs.
5. This MOU shall enter into force upon the date of signature by representative of both parties. It shall continue for a period of 5 years and renewable for a duration as agreed upon by both Institutions.
6. Either party reserves the right to terminate this MOU at any time, with or without cause, by giving written notice to the other party, no later than six months before the proposed termination date, although such action shall only be taken after mutual discussion with a view of avoiding convenience to the Parties.
